COMMENTS:

1. Of the twelve claims pending at year end, ten, totaling \$1,862,888, were not ripe for adjudication in the 2007-2008 reporting year because either the accused attorney had not been disbarred or suspended or the first anniversary of a disbarment /suspension was not reached before year end (May 31, 2008). The other two claims pending at year end, totaling \$168,278, were received in the last two months (April and May) of the reporting year.

2. Assessments received in the reporting year (\$65,410) are much reduced as compared to the prior year (\$242,445) because the supreme court reduced the assessment for the fund by 65% effective at the beginning of the reporting year.

3. Income Earned is from deposits in New Hampshire banks and in U.S. Treasury instruments.

4. The fund balance at the end of the reporting year is less than the balance at the beginning of the year because the claims paid in the year (\$151,500) were greater than the income received in the year (\$142,822).
