Public Sector Governor Criteria:

Must currently be employed in a qualifying position: in government service, military service, law enforcement, public interest law services (including prosecution, public defense, legal advocacy in low-income communities or for individuals with disabilities at a nonprofit organization), or at an organization that is described in section 501(c)(3) of the Internal Revenue Code of 1986 and exempt from taxation under section 501(a) of such Code, or at an organization recognized by the IRS as tax exempt under section 115.
